

### **Managing Paper Cards**

EverCheck automatically verifies eCard numbers from the primary sources listed above. However, if a professional has a paper card, they can submit it via EverCheck Wallet, our self-service application. From there, the card will be sent to a queue for review on EverCheck's Pending Credentials Report.

Certifications submitted via EverCheck Wallet and approved by your team will be added to the employee's profile and returned to your HRIS system. Customers can also bulk-add AHA or RQI certifications into EverCheck for ongoing verifications.
